In addition, you assign the nonexclusive worldwide right

to use the Work to promote and publicize ABI or its publications, including the right to use your name and likeness and biographical data in such promotions. If published, you will be identified as the author of the Work, or co-author if applicable.

**Warranty:** You warrant that the Work is original with you, that it is not subject to any existing copyright and that you have authority to grant the rights in this Agreement; that its publication will not libel anyone or infringe on or invade the rights of others and will not cause harm to anyone; that you have full power to make this agreement, and that the Work has not been published elsewhere in whole or in part (except as may be set out in a rider attached herewith). Should the Work contain any material that requires written permission for inclusion in the Work, you agree to obtain such permission from the copyright proprietor consistent with this Agreement.

You acknowledge that execution of this agreement does not obligate ABI to publish your work, and that ABI shall have complete and sole discretion to edit all manuscripts submitted for publication. By executing this agreement, you agree to withdraw duplicate submissions or substantially similar versions of this Work from publishers other than ABI, until such time as ABI has published this Work and has granted reprint permission, or until ABI notifies you of its decision not to publish this Work.
